The Complaint Committee shall look into all the cases relating to sexual harassment of Students/Employees working in the University, investigate the same as per procedure laid down in the act and rules made therein and make recommendations to the Competent Authority for decision.

The complaint committee shall ensure complete confidentiality and shall not disclose the contents of the complaint, identity and address of complainant, respondent and witness and information pertaining to conciliatory/inquiry proceedings or recommendations of the committee into the complaint to anyone as it is totally prohibited under the provisions of the said Act.
