# A) For Technical Courses (B.Tech., M.Tech., MBA, MCA & B.Design)

As per the academic calendar published by AICTE for technical courses for the year 2023-24, the Competent Authority of University has approved the fee refund policy for Technical courses for the session 2023-24 accordingly as under:

## B) For Ph.D

For withdrawal and refund of fee in respect to Ph.D admissions 2023-24 the competent authority has approved the following guidelines:-

- a) Withdrawal before the last date of admission\* full refund of fee after deducting Rs. 1000/- as processing charges
- b) In case of withdrawal between last date of admission\* and commencement of course work\*\* full refund of fee after deduction of Rs. 5000/-.
- c) In case of withdrawal within 15 days of commencement of course work\*\* 50% of fee will be refunded.
- d) No refund in case of withdrawal after 15 days of commencement of course work\*\*.

\*Last Date of Admission in PH.D July 2023-24 Batch is 29<sup>th</sup> August, 2023 \*\* Date of Commence of Course Work classes is 05<sup>th</sup> September, 2023

#### C) For Non -Technical Courses (Courses other than Technical Courses)

Till date the University Grants Commission has not issued any guidelines for fee refund for the academic session 2023-24, therefore, the competent authority has approved previous year guidelines of UGC for Non-Technical Courses (Courses other than Technical Courses), as under:

a)	Last date for cancellation of seats with full refund of fee	
b)	Last date for cancellation of seats with a refund of fee after deduction of Rs. 1000/- only	31st October, 2023
		31st December, 2023
