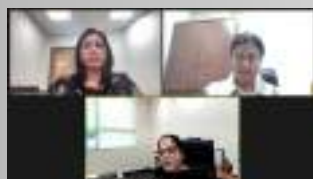
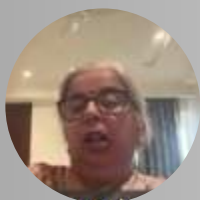

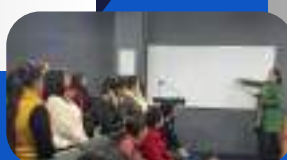

FACULTY ACHIEVEMENTS

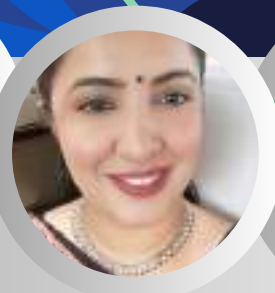
