The Board of Discipline shall perform the following functions:

- 1. To consider the matter concerning maintenance of discipline among the students in the University.
- 2. To enquire into the act of indiscipline or misconduct committed by a student(s) whenever such cases are referred to the Board of Discipline and to submit their findings, conclusions, and recommendations for the quantum of punishment under the provision of this Ordinance.
- 3. To supervise and monitor the discipline ecosystem prevailing in the University.

- 4. To maintain liaison with the police authorities and concerned departments of the Government, neighboring institutions and the authorities of the University regarding maintenance of Law and Order in the University.
- 5. To organize counseling session and liasioning with parents of the guardians of the students.
- 6. To perform such other functions as may be assigned to it by the Vice Chancellor from time to time.

The members of the Board including Chairperson shall hold office for a period of two years provided that the Vice Chancellor may re-constitute the Board of Discipline at any time before the expiry of this period of two years.

Provided further that until the new Board of Discipline is re-constituted or the existing Board of Discipline shall continue to act till such time new Board of Discipline is formed.

Three members of the Board of Discipline, including the Chairman, shall form the quorum.

In the absence of the Chairman, the senior most professor of the Board of Discipline shall act as Chairman.
